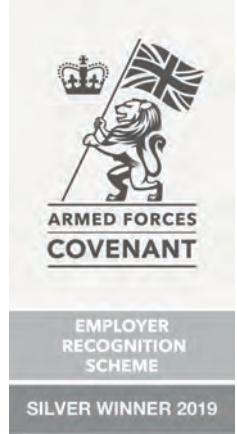


Our Pledge to the Armed Forces
